

A G R E E M E N T

THIS AGREEMENT made between the Village of Monticello, Green Co, Wisc. party of the first part, and the Townships of Washington, Green Co., Wisconsin and the Township of Mt. Pleasant, Green Co., Wisconsin, parties of the second part this 20th day of February 1938 regarding the housing and maintenance of Fire truck owned by the parties of the second part to be accepted as follows:-

1st. This fire truck shall be owned by the parties of the second part, but may be used at any time by the parties of the first part for the protection of the buildings or other fire hazards within the village of Monticello, Green Co., Wisconsin.

2nd. The costs of operation of the above mentioned fire truck shall be equally borne by the Village of Monticello, The township of Washington, and the Township of Mt. Pleasant. Accounts are to be kept by the Village Clerk of the Village of Monticello, and bills rendered at regular intervals to the respective townships.

3rd. Compensation insurance shall be carried on this truck, by a recognized insurance company, the costs to be divided as above provided.

4th. The party of the first part agrees to house at all times the above mentioned truck, in a heated garage, available to the properly designated members of the fire department of the Village of Monticello. Firemen for its operation to be furnished by the village of Monticello.

5th. Public liability, property damage, fire and theft insurance shall be carried by the parties of the second part, the costs to be paid in entirety by the parties of the second part.

In witness thereof the parties of the first and second parts do hereby affix their respective seals thru their proper officers, with the understanding that this agreement shall be made for the period of ten years, and to be further extended at the discretion of the then officers of the Village of Monticello, Township of Washington, and Township of Mt. Pleasant. Green Co., Wisc.
