

Town of Mount Pleasant
Resolution for Electors to Exceed the Levy Limits at Special Town Meeting of the Electors
14 November 2016

Whereas, the State of Wisconsin has imposed levy limits under s. 66.0602 of the Wis. Statutes for the tax levies in 2016 and thereafter;

Whereas, s. 66.0602 (5) of Wis. Statutes allows the town electors in towns under 3,000 in population to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of the electors;

Whereas, the town board has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Mount Pleasant;

Whereas, a Special Town Meeting of the electors has been called and noticed to consider the adoption of a resolution to endorse the town board's resolution to exceed the state levy limits; specifically by increasing the allowable town tax levy for 2016 (collected in 2017) by 76.50 percent;

Now, therefore, the special town meeting of the Town of Mount Pleasant, Green County, Wisconsin, by a majority vote of the eligible electors voting on this 14th day of November, 2016 duly assembled and voting rresolved and ordered as provided in the attached resolution, which accomplishes the following purpose:

BE IT RESOLVED, the town electors of the Town of Mount Pleasant Green County, Wisconsin endorse the town board resolution to increase the town tax levy for 2016 (collected in 2017) by 76.50 percent over the allowable 2016 levy, which is an increase of \$100,000 over the allowable 2016 town tax levy.

The town clerk shall properly post said attached resolution in 3 places or publish said resolution once in a newspaper as required by law under s. 60.80 of Wis. Statutes within 30 days of adoption.



Number of town electors voting aye =35



TOWN OF MOUNT PLEASANT
RESOLUTION OF SPECIAL TOWN MEETING
November 14, 2016

WHEREAS, the State of Wisconsin has adopted levy limits on town levies for 2011 and thereafter under Wis. Stat. §66.0602; and

WHEREAS, Wis. Stat. §66.0602 allows the town electors in towns under 2,000 in population to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of electors; and

WHEREAS, the Board of Supervisors of the Town of Mount Pleasant has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Mount Pleasant, in order to provide additional funds for repair of town roads; and

WHEREAS, this special town meeting of the electors has been called and noticed to consider the adoption of a resolution to endorse the resolution of the Board of Supervisors to exceed the state levy limits, specifically by increasing the allowable Town of Mount Pleasant tax levy for 2016 (collected in 2017) by 76.50 percent;

THE SPECIAL TOWN MEETING OF THE TOWN OF MOUNT PLEASANT by a majority vote of the eligible voters voting on this 14th day of November, 2016, duly assembled and voting, resolves and orders as follows:

BE IT RESOLVED, the town electors of the Town of Mount Pleasant approve the following actions by the Board of Supervisors of the Town of Mount Pleasant:

- (1) That the Town of Mount Pleasant Board of Supervisors commit to allocate not less than \$70,000 from existing revenue sources to repair of town roads as defined in Items 1-10 for construction expenditures in the Transportation Aids Cost Reporting Manual (updated December 2014), with such commitment to be on a best efforts basis, subject to emergencies caused by weather or other similar unforeseen circumstances; and
- (2) That the Town of Mount Pleasant Board of Supervisors commit to allocate the entire amount of new revenue added to the Town of Mount Pleasant levy limit by this town meeting to repair of town roads as defined in Items 1-10 for construction expenditures in the Transportation Aids Cost Reporting Manual (updated December 2014); and

BE IT RESOLVED, that in order to accomplish the actions described in the foregoing resolution, the tax levy for the Town of Mount Pleasant for 2016 (to be collected in 2017) shall be

increased by 76.50% over the allowable 2016 town tax levy, which is an increase of \$100,000 over the allowable 2016 town tax levy. This increase shall be ongoing.

THE TOWN CLERK shall properly post this resolution in three places or publish this resolution once in a newspaper as required by law under Wis. Stat. §60.80 within 30 days of adoption.
